>> On May 7, PHMSA issued Advisory Bulletin ADB-2012-06 regarding records verification for establishing MAOP for gas transmission pipeline. Beginning in 2013, PHMSA intends to require operators to submit data regarding verification of records in Class 3 and Class 4 locations and in Class 1 and Class 2 locations in High Consequence Areas (HCAs) via the Gas Transmission and Gathering Systems Annual Report. This information will then be used by PHMSA to develop additional guidance and/or rulemakings with regard to: (1) how operators will be required to bring their gas and liquid pipelines without verifiable records into compliance for the entire mileage of the pipeline; (2) how operators will be required to reestablish MAOP; and (3) whether to eliminate the grandfather clause under 192.619.
