This afternoon, PG&E delivered 5 copies of a CD containing the <u>confidential</u> supporting information for lifting operating pressure restrictions on Line 131-30. For your reference, maps of the pipeline and pressure test summary tables are attached. These will be included with the final filing. Sunil:

As a follow-up to our Revised Pressure Restoration Timeline for 2012 filings (attached), PG&E is on track to file a request for restoration of L131 in late-May. Due to wet weather in March, we were slightly delayed in our hydrotesting efforts. In order to get a full package of supporting information for your pre-review, we propose an early sharing of our filing to CPSD on Thursday, May 3. Our proposed filing schedule would allow for 8 business days for your review of the full package.

As shown in PG&E's 12-month timeline, we generally plan to file approximately two to three months in advance of the needed pressure restoration. Line 131 is an essential alternate supply to Milpitas and

the San Francisco Peninsula. There will be potential impact under *warmer* demand conditions if the capacity of the primary supply is diminished and L131 pressure is not restored. Deliveries to Milpitas and Hollister and downstream noncore customers are particularly at risk during warm summer weather. Because of this risk, our proposed schedule calls for a Commission decision at the August 2 Commission meeting.
