On a another note, regarding follow-up reviews being performed in response to the finding in Marin County, in its May 25th report PG&E states: "If PG&E finds additional instances of the above issue, we will report them to the CPSD." We would like for PG&E to report the results of its follow-up actions whether or not any additional instances are found. In fact, since the findings related to follow-up reviews performed by PG&E are important to all ALJ-274 violations reported, this type of follow-up report has to be an integral, routine, part of the reporting process for all ALJ-274 reports. The follow-up reports need to confirm if the reviews were performed company-wide or limited to the Division/District level. If performed on anything other than a company-wide basis, rationale for limiting the review has to be provided.
