**CONFIDENTIALITY DECLARATION FOR  
2012 RENEWABLES PORTFOLIO STANDARD PROCUREMENT PLAN

I, the undersigned, declare under penalty of perjury:

(1) I am the attorney representing Tiger Natural Gas, Inc. (“TNG”) in this proceeding;

(2) An officer of TNG was not located within the County of Los Angeles at the time this Confidentiality Declaration was filed;

(3) I am authorized to make this Confidentiality Declaration on TNG’s behalf;

(4) I have reviewed, or caused to be reviewed, the 2012 RPS Procurement Plan (“Plan”) referenced in this Confidentiality Declaration;

(5) Certain information contained in spreadsheet attached to the Plan as Attachment A, as specified in the table below, is eligible for confidential treatment under the provisions of Decision No. 06-06-066 and the Matrix of Allowed Confidential Treatment Energy Service Provider (ESP) Data (“ESP Matrix”) adopted therein and modified by Decision No. 08-04-023, said information is not already public, and the Commission is therefore obligated to protect said information so as to avoid material harm to TNG and its customers:
