



 General Counsel to help the growing and ambitious company navigate the legal

 challenges associated with developing and building natural gas power plants and selling

 power into the newly formed competitive power markets. In 1998, with the importance

 of governmental and regulatory affairs to Calpine growing, Joe took the reins of our

 Governmental and Regulatory Affairs group with responsibility for Calpine's political,
