MOTION OF ENERGYSOURCE LLC FOR PARTY STATUS

Pursuant to Rules 1.4 and 11.1 of the California Public Utilities Commission’s Rules of Practice and Procedure, EnergySource LLC (“EnergySource”) submits this motion to become a party in this proceeding.

EnergySource was formed in 2006 as an independent power producer to develop geothermal projects in the Salton Sea resource area, one of the largest and highest temperature geothermal resources in North America. In early 2012, EnergySource successfully completed the construction and commenced operations of its first major power plant, Hudson Ranch 1, the first stand-alone geothermal plant built in the Salton Sea resource area in 20 years. Over the next decade, EnergySource will seek to develop additional geothermal projects in the Salton Sea resource area to help California meet the goals of the renewables portfolio standard (“RPS”) program.

EnergySource is interested in opportunities to develop additional renewable projects to help California meet its RPS goals, and as such has an interest in the matters that will be discussed and determined in this proceeding.
