Thanks, Michael. Brian, actually [Redacted] has been a terrific point of contact - very responsive and helpful. Our challenge is with PG&E's responsiveness, as a whole, in terms of repairing broken lights. It takes too long, PG&E keeps paper records, and so forth. I held a hearing a couple of months ago, and these issues were all flagged and discussed. PG&E states that it is trying to improve things, but it's slow going. But in terms of actual response to my office, [Redacted] does an excellent job. If [Redacted] were the guy physically fixing the lights, we'd be in better shape.
