Development Rate Application, PG&E hereby provides the attached initial draft of a Standard Outline for use in the proceeding. Parties should comment by 9AM Thursday July 19. PG&E will do its best to incorporate comments and email out a revised, Joint Outline on Friday July 20 in advance of the second PHC on Monday, July 23.
