Colleagues:

Vote Solar originally served the attached reply testimony on July 23, 2012. The testimony did not contain any Internet links, thus I did not consider whether ALJ Gamson's "no Internet link" directives made during his July 9, 2012 Prehearing Conference applied. However, after receiving the supplemental testimony of other parties and re-reviewing the July 9, 2012 transcript, I determined that it would be better to err on including hardcopies of all citations not referencing served documents. Accordingly, the attached reply testimony now contains the hardcopies. **Other than indicating in the footnotes citing the hardcopy material that said material can be found in Attachment B, and of course the attachments themselves, the attached reply testimony is identical to that served on July 23, 2012.**

Because ALJ Gamson is out of the office until the day before hearings, I contacted Acting Assistant Chief ALJ Philip S. Weismehl regarding this late service and he subsequently granted Vote Solar permission to serve 1 day late.
