SUBJECT: WITNESS LIST FOR EVIDENTIARY HEARINGS, TRACK 1

The following is the tentative witness list for evidentiary hearings beginning August 7, 2012, based on cross-examination estimates and witness availability as considered in the July 9, 2012 Prehearing Conference and subsequent communications. I have attempted to take into consideration specific requests for dates certain, unavailability and other constraints; however, not all requests can be granted. This list is subject to modification, based on updated estimates due to forthcoming Reply Testimony and other information. The list will be revisited at the beginning of hearings.

Please be aware that these preliminary estimates for cross-examination (even without estimates for reply testimony) far exceed the number of hours available for hearings. As I noted at the July 9 Prehearing Conference, I intend to be vigilant in minimizing overlap, duplication and non-germane questioning. I reiterate that parties of similar interest should coordinate their questioning. There is little likelihood of scheduling further hearings; while I intend to allow sufficient opportunity to cross-examine witnesses, I will step in to cut off questions if necessary.

In order to provide better estimates before hearings, parties should provide to me via e-mail new estimates including reply cross-examination no later than August 3. Again, any coordination among parties of similar interests will be helpful. Any efforts to decrease overall time requirements will be appreciated. If parties are unable to sufficiently limit overall cross-examination estimates, I will do so.

Please be aware that I will be on vacation from July 16 through August 3.
