Pursuant to the "next steps" guidance at the July 6, 2012 CPUC Workshop on the PG&E Economic Development Rate Application, PG&E hereby provides the attached initial draft of a Standard Outline for use in the proceeding. Parties should comment by 9AM Thursday July 19. PG&E will do its best to incorporate comments and email out a revised, Joint Outline on Friday July 20 in advance of the second PHC on Monday, July 23.

As stated in the Energy Division's Workshop Agenda, the parties "will develop a standard outline they will use to discuss the issues in this case in all their submissions and responses in this proceeding, to facilitate use of common terminology and organization in such submissions." At the PHC on Monday July 23, "[p]arties are encouraged to structure their [short] oral reports using the standard outline," noting any areas in which their position might have changed.
