Hi -- no problem. I'm in the field tomorrow, but here's a quick "what I know right now" and I will try to catch you during the day/Thursday.

The week of 1/8-9 there is a large convention in the city, all hotel spaces with conference rooms have been taken, by a global JP Morgan event. The one location that we were able to get out of 10 that we tried is the Stanford Court Renaissance on Nob Hill. We don't personally have experience of an event at this location (though a million years ago I had dinner there!) -- so I can send some folks to check it out if we're interested.

The alternatives are: 1) keep with the current dates of 1/8-9 and commit to the Stanford Court (once we look at it), 2) keep the dates, but go outside of San Francisco, 3) change the date -- and get confirmation with Chairman Hersman, etc...

I'll try to think about any other alternatives, and then let's discuss. Also, we'll need a plan of how to engage the other utilities,
