**1. INTRODUCTION**

Pursuant to Rules 1.4(a)(4) and 11.1 of the Commission’s Rules of Practice and Procedure, Henwood Associates, Inc. (“HAI”) submits this motion to become a party in the above captioned proceeding.

**2. MOTION TO BECOME A PARTY**

*A. HAI’s Interest in the Proceeding – Rule 1.4(b)(1)*

HAI and its affiliates own and operate small hydroelectric generating facilities in California. Several of these projects current operate in PG&E's territory pursuant to Feed-in Tariffs. Among other matters, this proceeding is intended to make revised FiT contracts available and to allocate addition capacity to these contracts.

HAI is potentially interested in obtaining these new FiT contracts for new projects and projects with expiring contracts. Because the outcome of this proceeding will directly affect HAI's business HAI seeks to become a party to the proceeding for the purpose of providing input on the FiT contracts and the associated tariff.
