A number of ESPs have been in contact with Energy Division staff regarding the scope of and method for making supporting materials, including RPS contracts, available for Energy Division's review. ESPs require additional time to both complete their collection of materials (having not been previously aware that such a request from Energy Division would be forthcoming), to complete electronic conversion of older supporting materials, as well determining the most effective way of making the materials available to Energy Division.

During a call with staff on August 15, 2012, it was clarified that because earlier RPS verifications were previously completed, only contracts associated with the 2007-2010 period will need to be made available for review. Additionally, the use of electronic data room access was discussed as a potentially efficient option for ESPs to make their supporting materials available to staff for review. AReM raised the issue of an extension with staff and received indication of support for an additional 30 day period to secure and make available the supporting materials with an understanding that the RPS Closing Report templates would still be submitted on the August 20, 2012 date. Accordingly, the ESPs respectfully request an extension until September 19, 2012 to secure the supporting materials and establish a means to make those materials available for Energy Division review.
