All,

This afternoon I received a request from CPSD and PG&E to cancel the evidentiary hearings in this proceeding and to set a briefing schedule. I am reluctant to cancel hearings without first being assured that hearings are not necessary. The current request does not provide that assurance. Therefore, I am setting aside the morning of the first day of scheduled hearings, Thursday, August 23, 2012, to discuss the request, as well as the joint stipulation submitted by CPSD and PG&E regarding the use of assumed Specified Minimum Yield Strength values, which was served on August 15, 2012. This hearing shall begin at 10:00 a.m. Parties should be prepared to discuss both of these documents. Parties should also bring copies of their testimony to be entered into the record. This shall include CPSD's Investigative Report, dated May 25, 2012 (confidential and public versions) in its original form (i.e., as submitted on that date).

In the event it is determined that evidentiary hearings are necessary, witnesses should be available starting Friday, August 24, 2012.
