ALJ DeAngelis:

Pursuant to Rule 11.6 of the Commission's Rules of Practice and Procedure, Pacific Gas and Electric Company (PG&E) respectfully requests a twelve (12) day extension of time to file reply briefs concerning the Feed-In Tariff (FIT) form Power Purchase Agreement (PPA) and separate utility tariffs implementing the FIT Program consistent with D.12-05-035. Initial comments on the form PPA and tariffs were filed on August 15 and reply comments are due August 29. Given the volume of comments and proposals, PG&E believes that the parties and the Commission would benefit from a short extension of time to prepare reply comments. PG&E requests a twelve day extension so that reply comments would be due Monday, September 10.

Consistent with Rule 11.6, PG&E sent an e-mail to all of the parties in this proceeding yesterday, August 22, asking if parties supported or opposed an extension. No parties indicated an opposition to a request for extension. The following parties indicated they support PG&E's request: Placer County Air Pollution Control District, Clean Coalition, Jan Reid, Southern California Edison, and Solar Energy Industries Association.
