1. Serve the relevant portion(s) of its rebuttal testimony to the Zurcher testimony concerning assumed specified minimum yield strength (SMYS) values that it had submitted in I.12-01-007. (See RT, Vol 1-EH at 17:15-19). I have done a preliminary review of the rebuttal testimony in that proceeding, and believe that, at a minimum, the relevant portion is on pages 17 (line 5) through 18 (line 12).
2. Inform me of Mr. Berger's availability to appear as a witness on Thursday, August 30.

CPSD shall provide this information by close of business tomorrow, August 24, 2012.
