This is to confirm that these amounts are all transmission level expense, not distribution and not capital. Other kinds of work in this category include vintage pipe camera inspections and station testing requested by the NTSB, work on Line 132 (the insertion project, removal of pipe, etc.), and patrolling and work related to class and encroachment verification. These costs were either not contemplated in the last Gas Transmission & Storage rate case settlement (otherwise known as the Gas Accord) in D. 11-04-031, or San Bruno changed things such that the level of costs anticipated changed. Most items fall in the former category.
