Robert – per your request, we’ve reviewed the RPS Project Status table specifically focusing on the “online/in development/pending approval” status for PG&E’s projects and noted the items listed below.

1) Big Valley and Calpine Geysers have been terminated but are currently listed under “Approved and Online” tab.

2) Montezuma II Wind Energy Center has come online and should be moved to “Approved and Online” tab.

3) Pacificorp contract has expired.

4) Shiloh III Wind project has come online and should be moved to “Approved and Online” tab.

5) Vasco Wind Energy Center has come online and should be moved to the “Approved and Online” tab.

6) Global Ampersand, LLC – the most recent amendments for both contracts (Chowchilla and El Nido) have been approved and the facilities online, but both projects are listed in two tabs the “Approved and Online” tab and “Approved and in Development” tab.

7) Could not find the following projects in the table – unsure if different names/references may have been used:

- > Hidden Hills Ranch Unit 1

- > Hidden Hills Ranch Unit 2

- > Sandy Valley SEGS

- > Bottle Rock Power (2nd Amendment)

8) Rattlesnake Road Wind Power Project, Rice Solar Energy, and Sierra Power Corporation – have an amendment that’s pending approval – but this is currently in the “Approved and Online” tab.
