Hi Tom,

Eric Jacobson called last week to elaborate upon your request about rescheduling the meeting with MEA and AREM regarding their questions on the CHP/QF Settlement. I understand that PG&E is concerned that MEA would be able to use information from this meeting as part of their discovery within the concurrent ERRA evidentiary hearings. Eric suggested that we meet with MEA/AREM instead on September 17, until after the ERRA hearings have concluded.

Unfortunately Andy will be out on vacation during that time in September. In order to prevent further delay on resolving this issue, we would prefer to have the meeting either on August 28<sup>th</sup> or 30<sup>th</sup>. We recognize your concern about meeting with witnesses and would propose that Energy Division would help limit discussion to certain questions outlined beforehand. We can work with MEA and AREM to set an agenda that would be distributed prior to the meeting, with the caveat that PG&E may not be able to respond to questions if the answer would constitute an improper discovery of facts that could be used for purposes related to the hearing.
