California Water Service Company (Cal Water) hereby transmits for filing the following changes in its tariffs applicable to all district and four copies of each are attached hereto:

#### **Purpose**

This filing is to supplement the filing for Advice Letter 2084. In accordance with the provisions in Decision No. ('D.") 12-07-009, Cal Water is filing this advice letter to establish a twelve-month credit to refund \$1,141,919 recorded in the Temporary Interest Rate Balancing Account ("TIRBA"). Cal Water requests to retain the effective date from the original filing to facilitate programming in its billing system. Cal Water is also including two tariffs from the Bayshore District that were inadvertently excluded from Advice Letter 2084.

#### **Background**

On July 17, 2012, Cal Water filed Advice Letter 2084 to refund the balance from the TIRBA. Cal Water inadvertently excluded the count of flat-rate customers in the surcredit calculation for the Selma District. This filing incorporates the flat-rate customer count into the surcredit calculation, resulting in a smaller credit per customer in Selma.

On July 12, 2012, the California Public Utilities Commission ("Commission") issued D. 12-07-009, in Application No. 11-05-001, Cal Water's Cost of Capital proceeding. This decision adopted the Settlement Agreement between Cal Water (along with San Jose Water Company, California-American Water Company and Golden State Water Company) and the Division of Ratepayer Advocates. The Settlement Agreement, provides a rate of return of 8.24% for Cal Water for the period 2012-2014. Specifically, Ordering Paragraph No. 2 in D.12-07-009 states,

2. The capital costs and capital structures set out in Table I of this decision are approved.

The financial terms of the approved Settlement Agreement (Table I) in D. 12-07-009 for Cal Water is as follows:

Additionally, the Settlement Agreement allows for the disposition of the Temporary Interest Rate Balance Account that is maintained by Cal Water. Table II in D. 12-07-009 states,

TIRBA balance of \$1,141,919 will be amortized over twelve months via a customer surcredit. Within five days of the effective date of this decision, Cal Water shall file a Tier 1 Advice Letter to implement the surcredit.

#### Compliance

Cal Water is filing this advice letter in compliance with the provisions of D.12-07-009 and is authorized to return to its customers the \$1,141,919 recorded in the Temporary Interest Rate Balancing Account via a credit over 12 months.

Workpapers will be provided in the standard format.

The Temporary Interest Rate Balancing Account will be discontinued once the aforementioned balance has been fully amortized.

Cal Water will be filing a separate advice letter for the Cost of Capital rate implementations. Cal Water requests that the TIRBA credits be implemented on the same date that the other Cost of Capital changes will be implemented, which Cal Water will propose in the separate advice letter be September 1, 2012. This approach will allow programming of Cal Water's billing system for these multiple changes to be streamlined, will enable customer service representatives to explain the reasons for these related changes in a more comprehensive manner, and will help to mitigate customer confusion.

#### Additional Changes to Tariffs

Cal Water inadvertently excluded page 2 of 2 from both the BAY-MID-R-1 and BAY-MID-NR-1 tariffs from its advice letter filing. These are included in this supplemental filing

#### Tier Designation

Pursuant to D. 12-07-009, this advice letter is submitted with a Tier 1 designation. For the reasons discussed above, Cal Water requests that this advice letter be made effective on August 31, 2012.

#### **Requested Effective Date**

Under General Order 96-B, Water Industry Rule 7.3.1, as modified by Resolution W-4664, this is a Tier 1 advice letter. Cal Water requests this advice letter to have a later effective date of August 31, 2012, to allow for inputs to the utility billing system.

#### **Notice**

This advice letter is filed in compliance with Standard Practice U-27-W. No customer notice is required. In accordance with General Order 96-B, General Rule 4.3 and 7.2 and Water Industry Rule 4.1, a copy of this advice letter will be mailed or electronically transmitted on August 8, 2012, to competing and adjacent utilities and other utilities or interested parties having requested such notification.

#### **Response or Protest**

Anyone may respond to or protest this advice letter. A response supports the filing and may contain information that proves useful to the Commission in evaluating the advice letter. A protest objects to the advice letter in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

(1) The utility did not properly serve or give notice of the advice letter;

- (2) The relief requested in the advice letter would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies:
- (3) The analysis, calculations, or data in the advice letter contain material error or omissions:
- (4) The relief requested in the advice letter is pending before the Commission in a formal proceeding; or
- (5) The relief requested in the advice letter requires consideration in a formal hearing, or is otherwise inappropriate for the advice letter process; or
- (6) The relief requested in the advice letter is unjust, unreasonable, or discriminatory (provided that such a protest may not be made where it would require relitigating a prior order of the Commission.)

A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

A response or protest must be made in writing or by electronic mail and must be received by the Division of Water and Audits within 20 days of the date this advice letter is filed. The address for mailing or delivering a protest is:

Cities and counties that need Board of Supervisors or Board of Commissioners approval to protest should inform the Division of Water and Audits, within the 20-day protest period, so that a late filed protest can be entertained. The informing document should include an estimate of the date the proposed protest might be voted on.

The advice letter process does not provide for any responses, protests or comments, except for the utility's reply, after the 20-day comment period.

Replies: The utility shall reply to each protest and may reply to any response. Each reply must be received by the Division of Water and Audits within 5 business days after the end

of the protest period, and shall be served on the same day to the person who filed the protest or response.
