During the workshop, Staff will introduce a plan of analysis that follows the path set out in the Energy Storage Framework Staff Proposal to identify several priority end uses for energy storage systems, as adopted in D.12-08-016.

Phase 2 will also offer a more focused analysis of barriers and policy options, and will introduce

new tools for calculating the cost-effectiveness of storage applications. This approach will allow us to determine the need for storage in relevant situations and set targets, if necessary, to meet the directive embodied in AB 2514.
