Dear ALJ Gamson & R.12-03-014 (LTPP) Service List:

With apologies, EnerNOC, Inc., has further corrections to its cross estimates that have been previously provided.

Specifically, EnerNOC no longer intends to cross examine CAISO witness Sparks (substituting CAISO witness Millar in his place); no longer has cross examination for SCE witness Silsbee, and has switched time estimates for the two SCE witnesses Minick and Cabbell.

As corrected, EnerNOC's cross estimates are as follows:

CAISO Witness Rothleder – 45 minutes

CAISO Witness Millar – 30 minutes

SCE Witness Minick – 30 minutes
