MOTION OF CALPINE POWERAMERICA-CA, LLC FOR LEAVE TO FILE ITS CONFIDENTIAL UPDATED PROPOSED 2012 RPS PROCUREMENT PLAN UNDER SEAL

Pursuant to the California Public Utilities Commission ("Commission") Rules of Practice and Procedure, Rule 11.1 and 11.4 and Ordering Paragraph 9 of Decision ("D.") 08-04-023, Calpine PowerAmerica-CA, LLC ("CPA") respectfully files this Motion for Leave to File its Confidential Updated Proposed 2012 RPS Procurement Plan Under Seal ("Motion"). Concurrently with this Motion, CPA is filing its Updated Proposed 2012 RPS Procurement Plan. CPA's Updated Proposed 2012 RPS Procurement Plan includes a narrative response and an Appendix A. CPA is filing a confidential and public version of the Appendix A; the narrative response is public. Accordingly, CPA submits this Motion requesting an order for leave to file the confidential Appendix A to its Updated Proposed 2012 RPS Procurement Plan under seal.

In D.06-06-066, as modified by D.08-04-023, (collectively "Confidentiality Decisions"), the Commission adopted rules governing the confidentiality of certain electric procurement data submitted to the Commission by electric service providers ("ESPs"). In the modified ESP matrix attached to D.08-04-023, the Commission identified categories of information and the confidentiality protections to be applied to those categories. To the extent information submitted to the Commission by an ESP matches a category of information contained in the ESP

Matrix, the information is entitled to the protection provided for that category of information by the ESP Matrix.²

Attached hereto and incorporated by reference is a table identifying data for which Calpine PowerAmerica is seeking confidential treatment. As required by Ordering Paragraph 2 of D.06-06-066, the table specifies:

- 1. That the material Calpine PowerAmerica is submitting constitutes a particular type of data listed in the Matrix;
- 2. Which category or categories in the Matrix the data correspond to;
- 3. That Calpine PowerAmerica is complying with the limitations on confidentiality specified in the Matrix for that type of data;
- That the information is not already public; and 4.
- 5. That the data cannot be aggregated, redacted, summarized, masked or otherwise protected in a way that allows partial disclosure.

For the above reasons, CPA requests that confidentiality of cells identified in the attached table be treated as confidential information and not publically disclosed. Further, CPA requests an order for leave to file the confidential Appendix A to its Updated Proposed 2012 RPS Procurement Plan under seal.
