Please find attached the agenda for the Risk/Reward Incentive Mechanism workshop scheduled for Monday, August 20th from 10am-5pm. The workshop will be held in Hearing Room E, near the Auditorium, at the California Public Utilities Commission (505 Van Ness Avenue, San Francisco, CA). A carryover day of August 21st is reserved, as needed, to complete the workshop discussion.

We envision this workshop as a facilitated dialogue that will allow parties to brainstorm and hear from one another regarding reforms to the existing mechanism or new mechanism approaches, and to provide a forum to ensure parties are not "talking past one another," such that post-workshop comments are as useful as possible for the ALJ and Assigned Commissioner. Consequently, we have not identified panelists or presentations for the workshop, and have instead embedded into the agenda the questions from ALJ Pulsifer's July 30, 2012, ruling. (Please note that all of the questions included in the appendix to the ruling are available for discussion during the workshop -- the questions highlighted in the agenda are simply a summary of those questions for purposes of developing a framework of discussion.) Parties who do not believe a facilitated discussion based on the questions framed by ALJ Pulsifer are likely to encompass their concerns or ideas and would prefer to present separately should email me a description of your proposed presentation, as the carryover day could potentially be used for presentations as appropriate.
