- Filling in resource information for Local and System compliance
  - Listing single resource in multiple rows due to changes during year
  - Local RA compliance in template
  - Adding resources to NQC list, listing additional DR in DR tab

  - PG&E PTM to change filing dates, conform due dates to CAISO replacement rule -45 days before month. Ramifications on other RA rules such as CAM-RMR timeline.
