Hi Meredith,

I'm not sure how much time it would take for PGE to pull this together. We have a request internally here from the LTPP folks for more detailed location stats for contracted (operational or otherwise) DG projects under RAM, FIT, PV RFO, and PV UOG. So I'm attaching a spreadsheet and have highlighted in blue the "location columns" (columns P through T) that we're after on location.

Also, our intern put together the list of projects -- I'm not certain that it's full, complete, and up to date.

I suspect that PGE has this location information on file (I know I've seen some of it pop up in some spreadsheets from time to time) and that someone will just need to match it up. **Can PGE have this completed by COB next Tuesday, August 21<sup>st</sup>?**
