As noted below, PG&E will file our request to lift operating pressure restrictions on L300B tomorrow, September 20. Yesterday afternoon, PG&E spoke with ALJ Bushey regarding a schedule for this request. Following the discussions with ALJ Bushey, we plan to propose the following schedule in tomorrow's pleading:

This afternoon, PG&E will deliver 5 CDs containing a revised Exhibit B of the Line 300B pressure restoration early sharing material. This version contains test documentation for a 4-inch blow down stack on L300B that was not included in the original submittal. Other than some formatting edits, the remaining data in Exhibit B did not change. CPSD now has a full set of the filing material. PG&E plans to file our request to lift operating pressure on L300B on September 20 and will provide notice to the service list later today. If PG&E does not have CPSD's letter of adequacy by that time, PG&E will supplement our filing as soon as it becomes available. Please let us know when you expect to complete your review.

Sunil:

This afternoon, PG&E delivered 5 copies of a CD containing the confidential supporting information for lifting operating pressure restrictions on Line 300B. For your reference, a map of the pipeline and pressure test summary tables are attached. These will be included with the final filing. The supporting information provided on the CD is separated into two exhibits: L300B Mainline (Exhibit A) and L300B Branchline-Shorts (Exhibit B). These exhibits include a Pipeline Features List (PFL), MAOP Reports, and Strength Test Pressure Results (STPRs).

Also included below is a complete Operator Qualifications table for the work completed on L300B. PG&E is currently conducting a formal encroachment review, and will share the results with you in August, as soon as they become available.

We know you are busy, but we are hopeful that you are able to provide a letter regarding adequacy prior to our target filing date of September 7, 2012. PG&E is available to meet in person with CPSD to discuss the filing, if needed. I will be out of the office for most of August, so please contact Shilpa Ramaiya if you have any questions or concerns.
