Subject: I.12-01-007 - San Bruno Investigation - Opening Statements

NOTICE TO PARTIES IN I.12-01-007

By e-mail messages sent on September 18 and September 19, 2012, the City of San Bruno, a party in the proceeding, has asked whether opening statements will be permitted and, if so, when they will be heard. I will permit but not require parties to offer opening statements by counsel. Although the City of San Bruno intends to have the opening statement offered by the Mayor or City Manager, I am limiting the statements to counsel only. I note that the Mayor of the City of San Bruno is a witness in this proceeding. Opening statements are to be limited to five minutes and are to be limited in scope to an overview or outline of the evidence that the party will introduce by direct testimony or by cross-examination.

In the event that the Consumer Protection and Safety Division decides to offer an opening statement, it will go first, followed by non-Pacific Gas and Electric Company (PG&E) parties, then by PG&E.

Since the first day of hearings has been reserved for administrative issues in the morning and joint hearing with I.11-11-009 in the afternoon, time for opening statements is reserved for Tuesday, September 25, 2012 at the beginning of the hearing on that day.
