I spoke with the VA SCC pipeline safety group and they would be happy to host a visit from the California PSC to review the Damage Prevention program and risk based ticket / excavator tracking system they developed. I believe other states have visited the VA pipeline safety team for the same purpose, we are proud of the DP program in VA, and the DP record it has created. Washington Gas has less than one damage per thousand tickets in our Northern VA territory, a very congested and active area. This is the direct result of a solid and affective DP program.
