This afternoon, PG&E introduced exhibit PG&E-33 (I believe in connection with alleged violation #19 – missing or incomplete weld maps and weld inspection reports). This exhibit was CPSD's response to PG&E's data request 4, Question 21 and included the Weld Radiograph Log (MAOP05268942) referenced in CPSD's response. Mrs. Felts testified that the weld radiograph log included in that exhibit (MAOP05268942) was only the first page of Job File 123902, X-Ray documents and that this page was not representative of the incomplete weld inspection reports. I would like CPSD to have available tomorrow a page from Job File 12390, or any of the other job files listed in its response to PG&E's data request 4, Question 21, that Mrs. Felts considers to be representative of an incomplete weld inspection log.
