## CALIFORNIA ENVIRONMENTAL JUSTICE ALLIANCE'S MOTION TO CORRECT EXHIBIT IN THE EVIDENTIARY RECORD

The California Environmental Justice Alliance (CEJA) respectfully submits this motion to correct an exhibit in the evidentiary record in this proceeding. Public Utility Commission Rules of Practice and Procedure Rule 1.14(e) allows the Administrative Law Judge (ALJ) in a proceeding "to entertain appropriate motions concerning [a filed] document's deficiencies." Rule of Practice and Procedure 13.10 also allows an ALJ to receive further evidence.

CEJA originally served CEJA Exhibit CEJA-5, the Reply Prepared Testimony of Julia May on Behalf of the California Environmental Justice Alliance, on July 23, 2012 to all parties in this proceeding.

On August 17, 2012, during the evidentiary hearings in this proceeding, CEJA-5 was marked and received into evidence. During her direct examination, Ms. May made a correction to CEJA-5, which was to replace the word "Supplemental" in the title of the document with the word "Reply."<sup>2</sup>

On September 11, 2012, CEJA was notified that the copy of CEJA-5 that was entered into evidence was missing pages. Specifically, the copy of CEJA-5 received into evidence was miscopied and only the even numbered pages were included in the exhibit. While the copy of CEJA-5 that was moved into evidence was missing pages, the copy of
