Hi Jason,

This amendment does involve a price increase among other items. The amendment was evaluated against and chosen for execution using the same criteria as the 2011 RPS RFO shortlisted offers. The amended PPA is competitive with the 2011 RPS RFO shortlisted offers in both net market value and PG&E's Portfolio Adjusted Value. At the time of execution, the amended PPA ranked 2nd highest in PAV when compared to the shortlisted offers.
