Administrative Law Judges' Ruling on Motions of Consumer Protection and Safety Division

On September 7, 2012 the Consumer Protection and Safety Division (CPSD) filed two coordinated motions in Investigation (I.) 12-01-007, I.11-02-016, and I.11-11-009. In summary, CPSD requests (1) leave to serve additional prepared testimony regarding PG&E's financial resources in these proceedings and (2) permission to file a single coordinated brief regarding fines and remedies in these proceedings. In each motion CPSD asks for shortened time for responses to the motion. CPSD represents that it has informed parties in advance of its request and that no party indicated it would oppose the respective motions. Good cause appearing,
