E-Ruling

Administrative Law Judges' Ruling:

As part of a comprehensive ruling on the September 7, 2012 motions of the Consumer Protection and Safety Division (CPSD) that we plan to issue next week, we intend to approve CPSD 's request to serve additional prepared testimony regarding Pacific Gas and Electric Company's (PG&E's) financial resources. Since that ruling may not be issued until late in the week, we find it prudent to provide for service of the testimony at the earliest possible date. This will facilitate enable timely and coordinated processing of these matters. Therefore,

IT IS RULED that CPSD shall serve its supplemental prepared testimony on parties in the above-captioned proceedings on Monday, September 17, 2012. The assigned Commissioners and ALJs, PG&E, and Division of Ratepayer Advocates will receive unredacted confidential copies. Other parties, subject to appropriate nondisclosure agreements, may receive unredacted confidential copies.
