In PG&E's Gas Accord V, Phase II Decision, regarding safety protocols and procedures, the CPUC ordered PG&E to do the following in OP 1.b:

As part of PG&E's public safety and training efforts, PG&E shall be required to provide free training on natural gas to every fire department and agency on a regional basis in PG&E's service territory. (1) At least 45 days before the scheduled regional training, PG&E shall notify, by letter, the fire departments and agencies in the region of this free training opportunity. This training shall first be offered to those fire departments and agencies with gas transmission lines located in densely populated and urban areas. The training in these areas shall be offered starting no later than October 2011 and completed by June 2012. Subsequent regional trainings shall then be offered to other fire departments and agencies where gas transmission lines or gas storage facilities are sited in more rural areas. The training in the rural areas shall be completed by October 2012. After this natural gas training has been offered in all of PG&E's service territory, this training shall be repeated thereafter at three-year intervals.

In 2011 PG&E hired a contractor to identify all of the First Responder organizations (Fire Departments, Police, Sheriff, Highway Patrol, etc.) within PG&E's service territory. This effort resulted in approximately 1860 individual organizations that were initially contacted by mail and invited to attend free workshops. While awaiting responses, PG&E selected some of the key urban areas, organized and sent out information regarding specific workshops which were conducted in 2011. In 2011 PG&E conducted 11 workshops with 525 total attendees. All of these workshops were conducted by one employee. The location of the 2011 workshops is in Attachment 1.

In mid-2011, PG&E hired seven additional employees to deliver the First Responder Workshops. These seven individuals were selected based upon their previous experience as First Responders. With the title of Public Safety Specialist (PSS), these new employees

include prior Cal Fire, California Highway Patrol, County Fire, and others. PG&E has been training these new employees and in 2012 eight of them (one existing and seven new employees) are actively presenting workshops. The eight PSS's are geographically located throughout PG&E's service territory and one of their first assignments was to contact (via E-mail and follow-up phone calls) the First Responders in their area. All of the approximately 1860 originally identified agencies were contacted by the respective PG&E PSS. PG&E offered flexible scheduling, and made the PSS's available to come to the First Responder's locations on their schedules. PG&E focused initially on the urban areas – but we know that some of the rural departments traveled to attend in the urban areas. Attachments 2 & 3 are lists of all of those workshops that have been scheduled and conducted as a result of this effort. Additional workshops continue to be added as the PSS's continue to engage and build relationships with the First Responders in their areas (see Attachment 2 & 3).

In October, 2012, PG&E will be working with a new contractor to provide an updated list of all of the First Responder organizations within PG&E's service territory. This effort is being undertaken to ensure that the most up-to-date information is available for contacts. The eight PSS's will use the new list to, once again, contact each agency and follow-up to encourage participation in the workshops that are offered. As word has spread in the First Responder community (regarding the quality of the workshops), more agencies are becoming interested and responding to PG&E's offer to provide free training.

PG&E has delivered 331 First Responder workshops/trainings year to date (through October 3, 2012). Total number of 2012 participants: 7,453. PG&E is confident that this process identified all of the appropriate organizations and training has been offered and conducted covering all of PG&E's gas service territory, both urban and rural. In addition, the PSS's are continuing to follow-up with all of these agencies offering additional training, drills, and exercises when there is interest. PG&E will continue to build upon the relationships that the PSS's are establishing with First Responders and will repeat this training at regular intervals, in most cases, more frequent than a three-year interval.
