Subject: Unusual Event Exited at Diablo Canyon

PG&E Officers;

Diablo Canyon Power Plant Units 1 and 2 exited the Unusual Event this morning at 11:42 a.m.

As a recap, at 12:09 a.m. today, some small movement was detected in the control room. After confirming an earthquake occurred approximately 90 miles north of the station (near King City), our Shift Manager declared an Unusual Event, which is the lowest classification in our emergency response procedure. Both Units remain at 100 percent power with no impact to safety or operations.

Our plant staff effectively mobilized and implemented our procedures, including thorough plant walk-downs. As always, we appreciate the support of our entire PG&E organization in working through this challenge.

Subject: Unusual Event declared for earthquake felt at Diablo Canyon

PG&E Officers;

This note is provided for your information. An Unusual Event (UE) was declared for Units 1 and 2 at 12:09 a.m. (0009) on Sunday, Oct. 21 after slight movement was felt in the Control Room following a 5.3 magnitude earthquake that occurred outside of King City (approximately 90 miles from the plant).

Both Units remain stable and are operating at 100 percent power. DCPD personnel continue to closely monitor the plant and we will inform you once we exit the UE. In an effort to continue to keep our community informed, a media release will also be issued once the event has been successfully exited.

We will be communicating to plant employees in a similar fashion.
