Subject: I.12-01-007, I.11-02-016, and I.11-11-009 - PG&E Natural Gas Transmission
Investigations - Extension of Certain Due dates

NOTICE TO PARTIES

On October 5, 2012 the Consumer Protection and Safety Division filed a motion in the above investigations and in R.11-02-019 to suspend proceedings in order to facilitate negotiations toward a stipulated outcome. At this morning's evidentiary hearing in I.12-01-007, Administrative Law Judge Wetzell temporarily suspended the evidentiary hearing in that proceeding and continued it to Monday October 15, 2012.

The schedule for supplemental testimony and briefing adopted in our joint ruling dated September 25, 2012 provides, among other things, that both concurrent opening briefs in I.11-11-009 and intervenor financial analysis testimony in the three investigations noted above are due October 9, 2012. In view of the one-week continuation of the hearing schedule in I.12-01-007, we will extend the due dates for both the opening briefs in I.11-11-009 and the intervenor financial testimony by one week to October 16, 2012.

Parties have proposed without objection that additional testimony of Pacific Gas and Electric Company witnesses John Zurcher and Kris Keas be heard on a joint record in I.12-01-007 and I.11-02-016. This proposal is approved.
