The 2013 System RA template has been reposted, as has the 2013 RA Guide. Both have errors corrected. The DR tab was not picking up the DR information from the LSE allocation page, and the RA Guide incorrectly stated that the Local RA allocations were net of DR. We are also posting a redlined version of the RA Guide that is redlined against the 2012 RA Guide.
