Subject: Implementing AB 1900

John and Lee: We need to gear up for implementation of AB 1900 which requires the CPUC to issue a rule or order by December 31, 2013 establishing human and pipeline safety and integrity standards for biomethane injection into regulated utility pipelines. Biomethane that meets those standards must be accepted into utility pipelines.

The bill requires that by May 15, 2013, Office of Environmental Health Hazard Assessment (OEHHA) acting as the lead agency and working with the Department of Toxic Substances Control, California Air Resources Board, CalRecycle, and the California Environmental Protection Agency (collectively the "Agencies") must determine health protective levels for constituents of concern found in biogas.

I would like to set up a meeting with your staff and CPUC staff from Energy Division, CPSD and Legal to start formulating a plan of action. All of us would be well served by making sure that the OEHHA scopes out its task such that the CPUC gets the right input from them for its own proceedings that follows OEHHA's.

Please let me know who I should invite from PG&E and Sempra. Thanks
