CPUC JOINS WITH LAW ENFORCEMENT ON STRIKE TEAM

TO ENFORCE SAFETY COMPLIANCE OF PASSENGER CARRIERS

AT MAJOR AIRPORTS AND OTHER AREAS OF INTERESTS

SAN FRANCISCO, October 30, 2012 – The California Public Utilities Commission (CPUC) participated in seven multi-agency strike force operations on passenger carriers (limousines, shuttles, tour buses) during the third quarter of 2012. These operations were conducted to ensure that companies are properly licensed with the CPUC. The operations were conducted at the following locations:

 San Ysidro Border – July 9, 2012: The CPUC, along with the California Highway Patrol (CHP), conducted a surprise carrier inspection on two locations near the San Diego border. Approximately 50 shuttle vans and buses were observed and pulled over for the inspection. The CPUC issued three misdemeanor warnings (Workers' Compensation issues and revoked permit) and four observation reports (equipment not filed with the CPUC and use of a subcarrier).

- 2. Disneyland July 13, 2012: CPUC staff and the CHP conducted a surprise inspection in the Disneyland parking lot. Approximately 18 charter-party buses were pulled over for inspection. The CPUC issued three misdemeanor warnings (expired, suspended, and revoked permit) and three observation reports (equipment not filed with the CPUC). One charter-party bus that dropped off small children at the Disneyland parking lot was impounded by the CHP for having a revoked permit.
- 3. San Francisco International Airport (SFO) July 26 2012: The CPUC, the CHP, the Department of Industrial Relations (DIR), SFO Airport Police, and SFO Landside Operations conducted a surprise passenger carrier inspection. The CPUC interviewed 65 vehicle operators and issued 33 Notices to Correct Violations (suspended fees, vehicles not filed with the CPUC, waybills, vehicle ID, and possible Workers' Compensation violations). Subsequently, the CPUC issued pending suspension notices to four carriers for engaging employee-drivers without procuring evidence of Workers' Compensation insurance coverage. The DIR issued two citations for failure to have Workers' Compensation insurance, and the SFO Airport Police issued 12 citations (no proof of insurance, no registration card, suspended TCP, and license plate light out). The CHP inspected nine regulated vehicles, issued two citations (tires, equipment, and lights), and placed two vehicles out of service for equipment and tire problems.
- 4. Long Beach Airport July 27, 2012: The CPUC participated in an inspection of regulated passenger carriers operating at Long Beach Airport. The CPUC wrote 18 observation reports, mainly for violations of General Order 157-D, Section 3.01 (failure to possess a waybill or valid waybill and equipment not on file with the CPUC). The Long Beach Police issued seven citations for the same violations and also issued three citations for failure to have an airport permit prior to conducting ground transportation operations.
- 5. Modesto X-Fest Aug. 4, 2012: The CPUC joined the Modesto Police Department in patrolling the perimeter of Modesto's X-Fest from 4 p.m. until 2:30 a.m. The mission of the operation was to locate, inspect, and take enforcement action on party buses, buses, and limousines that were not operating with a valid CPUC permit and in compliance with state and local laws. Seventeen contacts/stops were conducted. Two arrests were made for operating without

charter-party authority. Citations were issued for 30 various California Vehicle Code violations, and four buses were taken out of service due to safety issues.

- 6. Golden Gate Park and Fisherman's Wharf Aug. 25, 2012: The CPUC and the CHP conducted two surprise inspections on the same day one at Golden Gate Park and another at Fisherman's Wharf. Approximately 30 buses were pulled over for the inspections. The CPUC interviewed 28 bus operators and issued four Notices to Correct Violations (equipment not on file with the CPUC, and missing vehicle ID). The CHP inspected 30 regulated vehicles and 35 violations were noted; one driver was taken out of service for a driver's license violation, and three vehicles were placed out of service for violations (no registration, equipment, and brakes).
- 7. San Diego State University (SDSU) Sept. 28, 2012: The CPUC participated in a surprise inspection hosted by the SDSU Police Department. Other law enforcement that participated in the operation included the CHP, San Diego Police Department, the Alcohol Beverage Control (ABC), and several other local enforcement agencies. Approximately 16 party buses/shuttle vans were stopped and inspected. The CPUC issued four observation reports for violations such as TCP name and number not shown on bumpers and on the side of vehicles. The CHP placed four carriers out of service for safety violations.

CPUC INVESTIGATIONS RESULT IN ENFORCEMENT ACTIONS AND FINES IMPOSED ON VARIOUS LIMOUSINES, SHUTTLES, AND BUS COMPANIES

SAN FRANCISCO, October 30, 2012 – The California Public Utilities Commission (CPUC), in its ongoing commitment to consumer protection, has recently taken a number of actions to protect consumers from illegally operating passenger carriers.

During the third quarter of 2012, the CPUC took the following enforcement actions against limousine, bus, and shuttle companies for violations of the Public Utilities Code and CPUC rules and regulations, including General Orders (GO) 115-F and 157-D.

Administrative Citation

Thirteen companies were cited and fined a total of \$15,550 for one or more of these violations:

1. Advertised a revoked permit number

2. Failed to enroll and/or pre-employment test drivers in a mandatory drug and alcohol program

3. Failed to enroll drivers in DMV Pull Notice program

4. GO 157-D violation (failed to maintain a current equipment list, no sub-carrier agreement, or incomplete waybills)

5. Operated without a valid authority (suspended or unlicensed)

6. Operated vehicles that are not insured at the required minimum level of public liability and property damage insurance

- 8. Failed to respond to consumer complaints

CPUC INVESTIGATIONS RESULT IN ENFORCEMENT ACTIONS AND FINES IMPOSED ON VARIOUS MOVING COMPANIES

SAN FRANCISCO, October 30, 2012 – The California Public Utilities Commission (CPUC), in its ongoing commitment to consumer protection, has recently taken a number of actions to protect consumers from illegally operating moving companies.

During the third quarter of 2012, the CPUC took the following enforcement actions against moving companies for violations of the Public Utilities Code and CPUC rules

and regulations, including Maximum Rate Tariff 4 (MAX 4), which contains maximum rates that carriers must observe as well as rules and regulations governing intrastate moves.

Administrative Citation

Pacific Relocation Services LLC (MTR 189900), based in San Francisco, was fined \$3,000 for the following violations:

1. Failed to provide the "Important Notice About Your Move" document at least 3 days prior to the move date;

2. Failed to provide shippers a complete Agreement for Moving Services and Freight bill; and,

3. Failed to provide the "Important Information for Persons Moving Household Goods" booklet.

Costal Moving Inc. (MTR190132), based in San Diego, was fined \$1,000 for failure to respond and provide access to business records upon request of an authorized representative of the CPUC.

Phone Disconnections

As part of its ongoing efforts to clamp down on illegal moving companies, the CPUC had telephone service shut off to two moving companies operating in California without a household goods permit. These companies continued to advertise and hold themselves out to engage in the business of transporting used household goods, notwithstanding CPUC staff directives to immediately cease and desist unlawful acts and to obtain a household goods permit.

 Zhiyuan Zhang, Qing Jie Li, Shengming Yu, Xiao Feng Xu, and Xia Li, dba Express Moving Services, A Plus Express Moving (MTR 189756): This company advertised and offered household goods moving services on the Internet. The advertisements listed five phone numbers and one fax number. Notwithstanding CPUC Cease and Desist letters directing the company to immediately cease all unlawful advertisements and operations, the company continued to violate the law as evidenced by the reviews on the Internet. On Aug. 3, 2012, the CPUC obtained a Finding of Probable Cause signed by an Alameda County Superior Court Judge. The Finding ordered disconnection of telephone service to the six numbers advertised and used by the company to violate criminal laws in the State of California.

2. Roberto Arias dba 24/7 Moving Services, E. Palo Alto (Unlicensed): This company advertised household goods moving services without proper authority on the Internet. The advertisements listed two phone numbers. Notwithstanding the CPUC's Cease and Desist letter directing the company to immediately cease all unlawful advertisements, the company continued to violate the law as evidenced by advertisements on the Internet. On Sept. 2, 2012, the CPUC obtained a Finding of Probable Cause signed by a San Mateo County Superior Court Judge. The Finding ordered disconnection of telephone service to the numbers advertised and used by the company to violate criminal laws in the State of California.

Criminal Filings

1. **Kenneth Robert Paiva, dba Next Transportation, Carson (MTR None)**: The CPUC submitted investigative findings and requested the Riverside County District Attorney's office to file a misdemeanor complaint against this company for operating without CPUC authority; failure to maintain in effect public liability/property damage and cargo insurance and Workers' Compensation insurance; and issuing a written estimate without first performing visual inspection of goods (MAX 4 Item 108(a) (1), in violation of Public Utilities Code (PUC) 5131, 5133, 5139, and 5161. The company was charged with a felony count of violating Penal Code Section 487(a), grand theft in the amount of \$3,870 and four counts of violating MAX 4 and PUC Code Sections. Arraignment was held in September and the defendant pled guilty and was ordered to pay restitution to a consumer in the amount of \$1,500, and pay investigative costs to the CPUC of \$500. He was also placed on probation for 36 months and ordered not to engage in any for-hire household goods moves in California without the proper authority.

Overcharges and Refunds

The CPUC assisted and/or directed moving companies to refund consumers more than \$17,000 for overcharges and other violations of the Maximum Rate Tariff 4.
