On October 5, 2012, the Consumer Protection and Safety Division (CPSD) filed a coordinated motion to suspend all procedural dates and activities in Investigation (I.) 12-01-007, I.11-02-016, I.11-11-009 and Rulemaking (R.) 11-02-019. On October 8, 2012, Judges Bushey, Wetzell and I issued a joint ruling setting a date for parties to respond to CPSD's motion.
