PG&E supports CPSD's motion to suspend all procedural dates and activities in these four dockets to allow the parties to concentrate their efforts on good faith negotiations toward a stipulated outcome to propose to the Commission.

Combined, these proceedings have been ongoing for nearly 20 months. Hearings have concluded in the Pipeline Safety Enhancement Plan proceedings (R.11 -02-019) and the Class Location OII (I.11-11-009), and are in progress in both the Records OII (I.11 -02-016) and San Bruno OII (I.12-01-007) with an anticipated end date of October 19, 2012. As the evi dentiary hearings to date have already demonstrated, decisions in these proceedings will require resolution of many complicated issues of fact and law.

Under the current schedule for the three OIIs, they will not be submitted until the completion of briefing on December 21, 2012. Presiding Officers Decisions (PODs) will likely be issued in the second half of February 2013, and a Commission decision would likely not be forthcoming before June 2013.

Where a fully -litigated outcome would extend these proc eedings – and the diversion of Commission and PG&E resources – until the middle of 2013 or later, the Commission could address a proposed stipulated resolution before the end of this year.

The Commission should grant CPSD's motion to suspend the current pr oceedings to allow the parties to concentrate their efforts on continuing and concluding discussions for a mutually-agreeable proposed stipulated resolution.
