Item 8.01 Other Events

The Current Report on Form 8-K dated October 12, 2012 and filed on October 15, 2012, by PG&E Corporation and Pacific Gas and Electric Company (the "Utility") is hereby amended solely to restate the parenthetical included in the first sentence of the third paragraph of the section entitled "*California Public Utilities Commission ("CPUC") Rulemaking Proceeding*" so that the sentence reads as follows:

In general, the ALJ recommends approval of the Utility's plan, but proposes to limit recovery of expenses to \$166.6 million (plus two months of expenses in 2012 assuming an effective date of November 1, 2012) and to limit recovery of capital expenditures to \$1 billion.

No other amendments are being made.
