At 8:00 pm EDT October 29, the National Hurricane Center reported Sandy made landfall near Atlantic City, NJ as a post tropical cyclone.

Employees are assembling at Sacramento. Safety and Expectations tailboard was performed at 1100 this morning. Pony Krueger, Tim Bedford, Ron Van Hoosear, Mike Swanson, Scott Rose, and union leadership will be present.

Charter flight is scheduled to depart from Sacramento (Mather Airport) at 1800 this evening with arrival in New York at 0100 Wednesday 10/31. We estimate our resources will be supporting the response for a one week period. Timeline will be trued up once on site.

88 employees have departed to support response. We expect an additional 22 employees to support the effort

Public Information Officer (Andrew Souvall)

- On Monday, October 29, External Communications developed and distributed news release on the wire and to all local media outlets throughout our service area. News release led to coverage from more than a dozen media outlets, including television, radio and print last night and early this morning. External Communications also conducted live interviews this morning with KCRA-TV and KOVR-TV in Sacramento.
- Posted a Currents story on Monday afternoon that was also leveraged on our social media channels Facebook and Twitter. Within three hours, the Facebook post was liked by more than 400 fans. (This is a very high number for a post that has only been up on Facebook for three hours.)
- On Tuesday, October 30, External Communications invited media to our Davis Yard to shoot video of equipment being sent New York. So far, all Sacramento television stations (KCRA (NBC), KOVR (CBS), KXTV (ABC) and KTXL (FOX)) have participated, and three television stations from San Francisco are on their way to shoot video early this afternoon.
- This afternoon, External Communications has invited media to Mather Airport to shoot video and interview crewmen who are leaving for New York.

Government Relation Liaison (Jessica Hogle)

Government Relations has been engaged both locally and in Washington D. C. to discuss transportation of vehicles and equipment. Contacted FEMA team in Washington DC who have offered assistance with DOT to grant waivers, while maintaining full compliance during the drive to New York. The team has worked with the FAA to provide priority take off and flight routes across the US.
