San Diego Gas & Electric Company (“SDG&E”), Pacific Gas & Electric Company (“PG&E”) and Southern California Edison Company (“SCE”) respectfully request an extension of the deadline to file comments and reply comments in response to the *Second Assigned Commissioner’s Ruling Issuing Procurement Reform Proposals and Establishing a Schedule for Comments on Proposals* (the “ACR”) issued on October 5, 2012. Comments on the ACR are currently due on November 15; reply comments are due on December 7. SDG&E, PG&E and SCE request that these dates be revised so that comments are due on November 28 and reply comments are due on December 19.
