Judge Wilson,

Counsel for the Alliance for Retail Energy Markets and I have conferred with respect to the matters raised in the Response to Motion filed by the Alliance this past Halloween. We are in agreement that the matters raised in the underlying and original Motion filed by SDG&E on October 16, 2012, should be clarified to the Alliance's satisfaction and in the manner they proposed in their Response. Although the Alliance had asked in its Response that the Commission direct SDG&E to clarify its Motion with respect to the manner in which direct access customers would receive their allocable share of refunds and credits received by SDG&E from the Department of Water Resources and that SDG&E respond with this clarification within fifteen days of the Commission's direction, we are in agreement on how the Commission should address the issues raised by the Alliance and are ready to file a Joint Reply to the Alliance's Response, with your permission, wherein we would provide our agreement and settlement of this matter.

We believe the receipt of the Joint Reply would facilitate an early disposition of this proceeding and fully resolve the matters raised by the Alliance to its satisfaction, and respectfully request your permission to file the Joint Reply on these grounds.
