By email on July 10, 2012, the joint parties of the R.11-05-005 service list requested an extension to submit the August 1, 2012 RPS Compliance Reports ordered by Decision (D.) 12-06-038. The request for extension was granted by Energy Division Director Edward Randolph on July 18, 2012, on the condition that all retail sellers would need to submit RPS Compliance Reports no later than 30 days after the date that Energy Division staff issue a final version of the new RPS Compliance Reporting format to the parties of R.11-05-005, as directed by D.12-06-038.

Commission staff and stakeholders collaborated on a preliminary annual 33% RPS compliance reporting spreadsheet. **All California retail sellers with an RPS obligation must submit a preliminary Annual 33% RPS Compliance Report using the reporting format provided by Energy Division staff, no later than December 28, 2012.** Detailed instructions for the qualitative and quantitative reporting requirements are outlined in the Instruction tab of the

preliminary Annual 33% RPS Compliance spreadsheet document. The preliminary Annual 33% RPS Compliance spreadsheet is available on the Commission's website:
