Judge Wilson,

Thank you for promptly setting the matter related to the Kern River Gas Transmission Transportation Services Agreement for further comments. On behalf of San Diego Gas & Electric Company, I would, however, respectfully request a delay in the schedule you set by thirty days.

As noted in our Opening Comments on your Proposed Decision, SDG&E expects to conduct discovery of the other parties prior to determining our position on the appropriate allocation of post-2012 Kern River TSA costs. We have not yet served our discovery requests, although we have requested informally that the Kern River TSA be and all documents describing the assignment of that agreement to the California Department of Water Resources be produced; as yet, we do not have those documents in hand. In large part, the nature of our discovery would be tied to the specific contractual provisions in these documents. Thus, no discovery by SDG&E has commenced as yet, and we expect our discovery will entail some collaborative back-and-forth with the Department of Water Resources, as well as a detailed review of our own internal historical records. Under ordinary circumstances, we would estimate this work would take thirty days to be completed. With the holidays intervening, we would expect personal absences would add to these time requirements and, thereafter, we would need some time during which we could finalize our position. We therefore request that the date for Opening Comments on the Kern River TSA be set for January 4th and Reply Comments for January 18th. I have not contacted any of the parties regarding this request, but we expect the workloads related to resolving the issues involved to be heaviest for SDG&E and would request the parties' indulgence with respect to our request for a change in schedule.

Thank you for your consideration of this request. We will, of course, commence our work immediately, pending your further rulings in this matter, and we will try to be prepared to meet your original schedule.
