This "11/27/12 Response" attached herein summarizes the closed/resolved issues and provides Energy Division's response to few remaining open issues that came out of the 11/9/12 meeting. Energy Division's expectation is that PG&E will file a supplemental advice letter proposing RCES modifications outlined in the "11/27/12 Response" column contained in the attached.

The energy Division suspended the Advice 3304-G/4052-E for 120 days beyond the originally requested effective date of June 30, 2012, to allow further review. PG&E agreed to a 30 day extension of the suspension period which will expire on November 30th. To allow time for ED review of PG&E's forthcoming supplemental advice letter we need PG&E to agree to an additional 30 day extension of the suspension period until December 30th. In light of this it would be most expeditious if PG&E sends me an email today agreeing to extend the initial suspension period by another 30 days until December 30th, 2012. The Energy Division is very

committed to completing its review of the AL once we receive your supplemental. The purpose of the extension is to avoid the need for ED to prepare a resolution. If you send an email today then I won't have to prepare a resolution tomorrow.
